A number of law firms and consumer protection groups are aggressively pursuing the setting aside of judgements and emoluments attachment orders with the final objective of securing a refund to consumers of funds received from the enforcement of court orders which were irregularly granted or perceived to be irregularly granted, often based upon their own incorrect interpretation of the law.
